LETTER OF REPRIMAND

TO: Mark Joseph Calvelo

The Registrar of the Real Estate Council of Alberta (RECA) has determined there is sufficient evidence you have contravened **section 40(1)** (e) of the *Real Estate* Act Rules and this is conduct deserving of sanction.

40 (1) An industry member must immediately notify, in writing, the executive director when:

(e) the industry member is the subject of any bankruptcy proceedings;

Particulars of the contravention(s):

- 1. On or around May 27 2020, you failed to immediately notify, in writing, the executive director when you became the subject of bankruptcy proceedings, contrary to section 40 (1)(e) of the *Real Estate Act* Rules:
 - a) On May 27, 2020, you were subject to bankruptcy proceedings
 - b) On September 29, 2020, you notified the executive director of the bankruptcy proceedings.

RECA's mandate includes consumer protection. RECA reviews certain events that may affect an industry professional's suitability for licensing and the public's perception of the industry. This is why you must immediately notify the Registrar in writing when any event listed under section 40(1) of the *Real Estate Act* occurs.

The Registrar considered the following aggravating and mitigating factors:

Mitigating Factors

• You have admitted to the conduct and have taken steps to educate yourself as to your obligations under Rule 40.

The Registrar will issue a more severe sanction for further similar instances of this conduct.

Appeal

You have the right to appeal this Letter of Reprimand to a Hearing Panel under section 40.1(2) of the *Real Estate Act*. Please refer to Guides on RECA's website for more information on the appeal process.

In an appeal you will be given a full opportunity consistent with procedural fairness and natural justice to present evidence before the Hearing Panel in relation to the contraventions alleged.
